Lee Doughtie



Pitch In!

Several months ago, our Bank initiated a new program, and in order for it to be a success, we need your help. It involves the process of shredding computer and classified paper for the purpose of recycling. Recycled paper is used in a variety of ways from boxes to tissues.

How can you do your part? Computer printouts and documents containing confidential information should always be shredded. The importance of destroying confidential records cannot be stressed enough. Collect the papers in your area that should be shredded ... be sure to keep this material separate from other trash. Shredding containers are located on every floor for your convenience. Collect your papers and deposit them in the receptacle located nearest your office area. Containers are located in the following areas:

Lobby – Teller Circle Second Floor – Commercial Teller Area Third Floor – Key Punch/Proof Fourth Floor – Data/Credit Cards Fifth Floor – Operations/Bookkeeping Sixth Floor – Accounting/Credit Operations Seventh Floor – Real Estate/Investments Eighth Floor – Trust Eleventh Floor – Personnel

If you have a large bulk of papers that you are unable to carry to the containers, call maintenance at extension 4675, and they will be able to assist you.

Right now we shred approximately 1,500 pounds of paper a week; let's do even better!
