School Savings Program

The First City, Texas School Savings Program idea was researched and brought to the attention of First City, Texas by **Christi Davidson**. In securing this program, First City, Texas - Austin has been granted exclusive rights to this program in the Austin Independent School District. In this joint effort with First City Bancorporation, the pilot program will be coordinated by **Lutie Little** and implemented in the following schools:

Casis Elementary
Doss Elementary
Maplewood Elementary

The First City, Texas School Savings Program is structured around a weekly School Banking Day. The students will be able to make deposits to their accounts, using their school computer, on a certain day and time each week. The banking day will be overseen by the school's respective PTO/PTA volunteers. This First Savings "passbook" account will earn 5 percent interest and will be credited to the account quarterly. Students keep records of their transactions in student savings registers and receive quarterly statements at home to reinforce use of their math skills. First City, Texas will waive the minimum opening balance, but it will still act as a regular First Savings account, with the account ownership in the child's name. In the program, only deposits are made at school. Withdrawals must and deposits may be made at First City, Texas - Austin locations with a parent/guardian signature required.

The classroom curriculum, endorsed by the U.S. Department of Education, teaches the students, grades three through six, how to manage their accounts and read their receipts and monthly statements. On a wider scale, it also teaches students the fundamentals of finance, the American banking system, and practical money management. This program encourages the good habits of savings at an early age on a regular basis.

With statewide potential, this further reinforces First City, Texas' commitment to education.


While doing the Collateral Department's vearly escheat audit on stocks and bonds. Cammie Morrison came across three Series E War Bonds issued in June, 1944, and March, 1947, with a face value totaling \$100. How many of us have even seen a war bond dating back to 1944? That was before a lot of us were even born! The war bonds were taken as collateral on a loan made to L. L. Wallace in 1948 by Fidelity State Bank, now known as First City, Texas - Austin. The bonds being reported in prior years had not been picked up by the state, so therefore still remained in our possession. Cammie was quite taken with these old war bonds and decided to show them to Teresea English, manager of the Collateral Department. Diane Hervol, noted

for being in the right place at the right time, just happened to be in Teresea's office when Cammie was showing the war bonds to Teresea. Of course, there was no hope of being able to locate the customer after 41 years. Just think what the odds would be of being able to do that! Diane, however, thinking of her motto, "nothing is impossible," picked up the telephone book and started looking for the name of Lacy L. Wallace (the name shown on the bonds). There it was in black and white, Lacy 1. Wallace! Could this be the same Lacy L. Wallace whose name appeared on the war bonds? Wasting no time at all, Diane called the number listed, and after speaking several minutes with Mrs. Wallace, she was able to verify that Mrs. Wallace did have some old Series E War Bonds that had been pledged as collateral to a loan. Upon the death of her husband in the sixties, she had lost track of some of their financial records and did not know what had happened to the bonds. Mrs. Wallace was very excited over the good news and promptly said that she would be down at the bank at 10:00 a.m. the next day to pick up the war bonds. Needless to say, we were all amazed and could not believe that after 41 years the owner of the war bonds was located and with such little effort on our part. That was just incredible!

Mrs. Wallace arrived the next day at 9:45 a.m. and visited for some time with Teresca. She appeared to be a very nice lady, happy and full of life, with lots of memories to tell about. Having decided that she wanted to cash in the war bonds, Diane jumped at the opportunity to escort Mrs. Wallace to the Collection Department where she helped her to cash in the bonds. Being very appreciative of the bank's effort to contact her, and especially of Diane's help in getting the bonds cashed, Mrs. Wallace showed her gratitude by sending a big box of candy to Diane which was shared with the rest of the Collateral Department. The whole amazing incident left all of us feeling really good, and we were especially happy for Mrs. Wallace.
